## **RULE 13.09 ANNOUNCEMENT**

Mr. Xu Wei, who holds a number of senior management positions at the subsidiary level of the Group, is now assisting the Commission with certain investigations.

This announcement is made pursuant to Rule 13.09 of the Listing Rules.

At the subsidiary level of the Group, Mr. Xu Wei is currently the chairman of the supervisory committee of Shanghai Transmission and Distribution, a vice chairman of the board of Shanghai Mechanical & Electrical, a director of the Shanghai Electric Finance Company, and a supervisor of Rail Traffic Equipment Development Company.

On 17 October 2006, the Company was notified by the Commission that Mr. Xu Wei is suspected of violation of certain rules and regulations of the PRC Communist Party in his personal capacity and for his personal acts, and is therefore now assisting in certain investigations being carried out by the Commission. The Company was also informed by the Commission that the said investigations do not relate to Mr. Xu Wei in respect of his senior management positions with the Group and are not directed at the Group or its assets.

Further announcements will be made in due course should there be any relevant updates or development.
